

CSU Student Success Network Advisory Board – Call for Nominations

The [CSU Student Success Network](#) (Network) is seeking committed and passionate individuals to serve on our Advisory Board. Established in 2016, the Network is an independent initiative developed by CSU faculty, staff, and administrators that brings people together to build knowledge, develop relationships, and take actions to advance equitable opportunities and outcomes for students.

The [CSU Student Success Network Advisory Board](#) is composed of up to 12 representatives from across the CSU who serve in a variety of roles. The purpose of the Advisory Board is to provide advice and guidance to support the Network in meeting its mission and goals.

If you are interested in serving, please compile your nomination packet (details below) by Friday, October 1, and send it to studentsuccessnetwork@edinsightscenter.org.

Commitment. Network Advisory Board members serve a minimum three-year term, with the option to serve up to three consecutive terms. Board member duties include:

- Attending both the Fall and Spring Advisory Board meetings (virtually this year);
- Providing advice and recommending actions to Network staff about Network programming and activities, communications, and finances;
- Providing guidance, support, and advice regarding the Network's finances;
- Communicating about Network activities to interested campus parties;
- Participating in Network activities or encouraging campus colleagues to participate; and
- Representing the Network in the community and on campuses.

Qualifications. In order to serve on the Network Advisory Board, you must be currently employed by a campus in the CSU as a faculty member, staff member, or administrator. The selection committee will be looking for:

- Demonstrated commitment to, and passion for, advancing equitable opportunities and outcomes for students;
- Proven experience cultivating relationships within and across campuses;
- Knowledge and experience related to student success efforts in the CSU; and
- Previous participation in one or more Network activities.

No campus shall have more than one member on the Advisory Board at a given time. Current Board members represent Channel Islands, Chico, Fresno, Monterey Bay, Pomona, Sacramento, San Diego, San Francisco, and San Marcos.

Compensation. Service on the Advisory Board is without remuneration except for administrative support for Network activities and travel reimbursement.

Nomination Process. Advisory Board candidates must be nominated by their President, Provost, or Vice President of Student Affairs. **To be considered for an Advisory Board position, please submit the nomination packet by Friday, October 1 to studentsuccessnetwork@edinsightscenter.org.**
