Major Outcomes

1. Summarize your project's outcomes against the original goals proposed for advancing equitable student learning, engagement, progression, and completion.

For Goal I (Increase community engagement and sense of belonging among students who identify within Southeast Asia and the Pacific Islands) we continue to host monthly peer to peer convenings. Led by student leaders, the project supported a APIDA leadership summit for students with a focused-on career readiness.

For Goal 2 (Establish a vanguard of SA/PI student leaders that are supported by faculty/staff mentors) we continue to provide intentional opportunities to engage faculty and staff with students through connections via cultural celebrations, holidays and similar background/interest. A mentor and mentee model has been established to support this process.

For Goal 3 (Raise awareness of the educational inequities in the SA/PI college student experience) A report on Southeast Asian student experiences has been completed and shared with stakeholders on and off campus..
